An Act to enable the President to establish corporations sole to facilitate the more efficient carrying on of commercial or industrial enterprises by public department

ENACTED by the Parliament of the United Republic of Tanzania.

- 1. This Act may be cited as the Corporations Sole (Establishment) short title Act, 1974.
- 2. In this Act "Minister" in relation to any corporation sole means Interpretation the Minister for the time being responsible for the department for which the corporation sole is established.
- 3. (1) Where the President is of the opinion that it is expedient or desirable to establish a corporation sole in order to facilitate the carrying on of any commercial or industrial enterprises by a public department he may, by order in the Gazette designate any public office to be a corporation sole.

- (2) Every order made under subsection (1) shall specify the public department in relation to which the corporation is established and may specify the commercial or industrial enterprise which may be carried on by the corporation.
- (3) Where any public office is designated to be a corporation sole the public officer for the time being holding or acting in the public office Shall have and may exercise all the powers of a corporation sole.
- (4) Every Corporation Sole Established by an order under this section shall –
 - (a) Have perpetual succession and a common seal;
 - (a) In its corporate name be capable of suing and being sued;
 - (c) Subject to the provision of this Act and any order made by the President in that behalf be capable of purchasing and otherwise acquiring, and of alienating any property, movable or immovable.

Function of Corporation Sole 4. (1) Every Corporation Sole shall carry on the commercial or industrial enterprise which it is authorized to carry on in an efficient manner and in accordance with the best mercantile traditions and

may -

(a) do anything or enter into any transaction which in its opinion is calculated to facilitate the proper and efficient carrying on of its activities and the proper exercise of its functions;

- (b) do all such acts and things as may be necessary to uphold and support the credit of the Corporation and to obtain and justify public confidence, and to avert or minimize any loss to the Corporation.
- (2) The Minister responsible for the public department in relation to which a Corporation Sole is established may give the Corporation such directions of a general or specific nature as he may consider fit and the Corporation shall give effect to every such direction.

Financial Provisions

- 5. (1) The funds and resources of a Corporation Sole shall be:-
 - (a) Such sums as may be provided by Parliament either by way of loan or grant,
 - (b) Such sums of money as the corporation may borrow;
 - (c) Such sums of money or other property as may in any manner become payable to or vested in the Corporation Sole by any written law or incidental to the carrying out of its functions.
- (2) A Corporation Sole shall not borrow any sum of money from any person other than the Government, the National Bank of Commerce, the Tanzania Investment Bank of the Tanzania Rural Development Bank, save in accordance with the Regulations made under this Act:
 - Provided that a person lending money to a corporation sole shall not be bound to enquire whether the provisions of this subsection have complied with.
- (3) Not less than two months before the beginning of any financial year (other than the first financial year) every Corporation Sole shall cause to be prepared and submit to the Minister and the Treasury registrar a detailed budget (in this Act called the annual budget of the amounts respectively-
 - (a) expected to be received; and
 - (b) expected to be disbursed,
- (4) If in any financial year a corporation sole requires to make any disbursement not provided for or off an amount in excess of the amount provided for, in the annual budget for that year, it shall submit to the Minister and the treasury registrar a supplementary budget detailing such disbursement.
- (5) The annual budget and every supplementary budget shall be in such form and include such details as the Treasury Registrar may direct.
- (6) The Minister shall, upon receipt of the annual budget or any supplementary budget and after consultation with the treasury Registrar approve or disapprove the same or may approve subject to such amendments as he may deem fit.
- (7) Where the Minister has approved any annual budget or supplementary budget, the budget, as amended by him, shall be binding on corporation sole, which shall, subject to the provisions of subsection (8). Confine its

disbursements within the items and the amounts contained in the applicable estimates as approved by the Minister.

- (8) A corporation sole may
 - with the sanction in writing of the Minister and of the treasury (a) registrar, make a disbursement notwithstanding that such disbursement is not provided for in any budget:
 - (b) from the amount of expenditure provided for in any budget in respect of any item, transfer, a sum not exceeding ten thousand shillings to any other item contained in such budget;
 - adjust expenditure limits to take account of commercial and (c) climatic changes not reasonably for seeable at the time the budget was prepared, subject to submitting a supplementary budget to the Minister and the treasury registrar within two months of such alteration of expenditure limits becoming necessary.
- (9)In this section "financial year" in relation to any corporation sole means the period commencing on the first day of July in any year and expiring on the thirtieth day of June in the following year:

Provided that the first financial year of a corporation sole shall commence on the date on which it is established and shall expire on the thirtieth day of June in the following year.

- 6. Every corporation sole established under this act shall be deemed corporation Tο be specified in Part II of the Schedule to the companies sole to be (Regulations of Dividends and Surpluses and miscellaneous specified Provisions)Act, 1972 and that Act shall apply to corporation company Accordingly. Acts, 1972 No.22
- 7. The Minister for the time being responsible for finance may make regulations regulating the administration of the funds and resources of public corporations.

THE CORPORATION SOLE (PRISON DEPARTMENT) REGULATIONS 1983

Short title

 These Regulations may be cited as the Corporation sole(Prison Department) Regulations, 1983.

Application

2. These Regulations shall apply to be corporation sole established in relation to Prison Department of the Ministry of Home Affairs.

Interpretation

- In these Regulations unless the context otherwise requires;
 "the Act means the Corporation Sole(Establishment) Act, 1974
 "Corporation" means the Corporation Sole to which these Regulation applies;
 - "Minister" means the Minister for the time being responsible to Home Affairs;
 - "Principal Secretary" means the Principal Secretary to the Minister responsible for Prisons.
 - "Specified Officer" means the Principal Commissioner of Prisons and any other Officer, holding or acting in the office which has been designated the Corporation Sole.

Bank

Accounts

- 4 (1) The specified Officer in relation to the corporation shall cause a bank account to be opened in the name of the Corporation and may with the approval of the Principal Secretary cause to be opened one or additional accounts at such bank or banks as the Principal Secretary may approve.
 - (2) the specified Officer shall ensure that are provided and kept books of accounts and records with respect of each bank account of the corporation.
 - (3) All monies which in any manner whatsoever are payable to the corporation in its capacity as such and are received by the corporation shall be paid into a bank account of the corporation.

Every bank account of the corporation shall be operated by the specified Officer or by such other public officers as may be authorized

in that behalf in writing by the specified Officer and approved in like manner by the Principal Secretary.

5-(1)For the purpose of this regulation "petty payment" means payments by withdrawals from cash of amounts not exceeding three hundred each the

bank any payments by the corporation

- (2) the specified Officer, may from time to time cause to be with drawn from the bank such amounts as are necessary to enable him to make petty not exceeding three thousand shilling in the aggregate on any one day.
- (3) All payments from the founds of the Corporation other that petty payments and in respect of wages of employees of the corporation shall be made by cheque and not otherwise.
- (4) The specified Officer shall cause to be:-
 - (a) Obtained and kept a receipt or other record in respect of every payment made by the Corporation; and
 - (b) maintain in triplicate a record of and disbursements made by the Corporation and shall within the first fifteen days of every month submit to the Principal secretary and the treasury registrar a copy of the record of disbursements made by it during the preceding month.

6. The specified Officer shall within two months before the commencement of any financial year, cause to be prepared and submitted to the Minister and the treasury registrar for approval, a detailed Annual budget showing the amount

1. This Order may be cited as the Prisons Corporation sole Board (Establishment) Order, 2006

Citation and commencement

- 2. In this order unless the context otherwise require
 - "Act" means the Corporation sole act, 1974;
 - "appointing authority" means the Minister,
 - "board" means a Board established, planning, discipline and finance of the prisons Corporation Sole;
 - "Chief executive officer" means the Prisons Corporation Sole;
 - "Corporation Sole" means the Minister for the time being responsible for matters relating to the Tanzania Prisons Service;
 - "Permanent Secretary" means the Permanent Secretary for the tie being responsible for matters relating to the Tanzania Prisons Service;
 - "Principal Commissioner" means the Principal Commission of Prisons, heading the Tanzania Prisons Service:
 - 3 (1) There is hereby established a Corporation Sole Board for Tanzania Prisons Service to b known as the Prisons Corporation Sole Board.

- (a) the chairman who shall be appointed by the Minister and who is knowledgeable, and experienced in Corporation sole management
- (b) the Principal Commissioner who shall be the Secretary;
- (c) a member representing the Ministry of Finance;
- (d) a member representing the Tanzania Investment Centre (TIC);
- (e) a member representing the Ministry responsible for Industries and Trade;
- (f) a member representing the Ministry responsible for Livestock Development;
- (g) a member representing the Ministry responsible for Agriculture and Cooperatives;
- (h) a member representing the Ministry responsible for Home Affairs; and
- (i) four other members at least two of whom, are Senior Prisons Officers, appointment by the Minister upon recommendation of the Principal Commissioner
- (3) The Board is a liberty to have not more than two co-opted members in every sitting provided that they are not entitled to vote.
- (4) The Board may invite any person to its meeting for proper deliberations of proceeding but such a person shall not be entitled to vote.
- (5) The Board on its first sitting shall elect a Vice Chairman who is not an employee of the Tanzania Prisons Service.
- the 4. The Secretariat of the Board shall be in the office of the Principal Commissioner. secreta riat

Tenure of

Office 5. A member appointed under subparagraphs (a) or (i) of paragraph 3(2) –

- (a) shall, unless his appointment is sooner terminated by the Minister as the case may be, or he ceases in any other way to be a member, hold office for a period of three years but may be eligible for reappointment;
- (b) may at any time resign his office by giving notice in writing addressed to
- (c) the Minister and from the date specified in the notice or if no date is so specified, from the date of the receipt of the notice by the Minister, he shall cease to be a member.
- 6.- (1) The Board shall ordinarily meet at any time and place as it deems necessary for the transaction of its business but shall, meet at least once in every six months.

- (2) The Secretary, after consultation with the Chairman or in his absence the Vice-Chairman, may at any time call a special meeting upon a written request by a majority of the members in office.

 - direct the Chief Executive Officer on any matter that may be referred to the Board by the Permanent Secretary or other higher authorities;
 - d) advise the Chief Executive Officer on any matter that may be referred to

Board by him.

- e) initiate project and programs for the general progress of the Corporation Sole and do any other activities within its capacity;
- f) Solicit contributions and donations within and outside the country, aimed at facilitating higher efficiency, effectiveness and productivity of the Corporation Sole projects.
 - g) promote better management and accountability of the Corporation Sole.
